**Alcohol must be served/consumed during the time stipulated in the permit only.** Please note a permit will not be issued for consumption of alcohol on a public roadway to extend beyond 11pm.

## Conditions for street closure

- The Street Party activities must not unduly interfere with normal pedestrian access.
- All barricades and street obstructions must immediately be removed in the event that access is required by emergency vehicles.
- Noise including amplified noise must be kept at a reasonable level so as not to cause annoyance to other people.
- Petting Zoos and jumping castles are not permitted on council land
- **The permit holder is responsible for ensuring the street is left in a clean and tidy condition and all rubbish is disposed of appropriately.**
- The permit holder is to abide to any reasonable direction given by an authorised officer of the City of Stonnington.
- Road closure barriers installed (in accordance with the *Road Safety Act 1986*, Section 99A) must not be tampered with or moved (unless an emergency arises) until they are collected by Council officers.
- The applicant acknowledges that the City of Stonnington does not accept any responsibility for accident, loss or damage, expense or injury, to participants, property or third parties, and the applicant agrees to accept responsibility for the Street Party.
- In accordance with clause 186 of the General Local Law, Council reserves the right to cancel, suspend or amend an approved permit at any time.

## Notification

Council will write to all residents directly affected by the road closure advising them about the road closure for the street party. They will have 7 days to lodge a written objection to Council for consideration.
